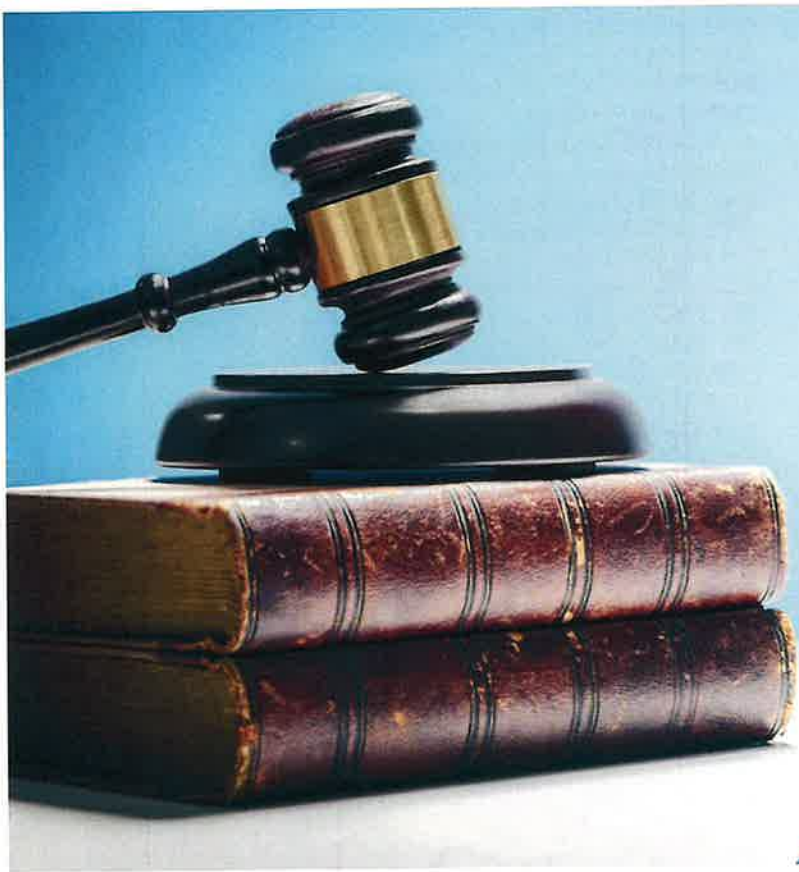

## **PREPARING YOU TO PURSUE A J.D. OR OTHER PROFESSIONAL LEGAL CAREER**

The pre-law minor at Eastern includes courses that develop abilities in analytical and critical thinking, in reading comprehension, and in communicating effectively in both the written and spoken language. Students report that the pre-law minor has been very helpful in their first and subsequent years of law school.

### **PRE-LAW INTERNSHIPS**

Internships are offered in a variety of agencies and private law firms. These include state's attorney, public defender, public interest agencies and private law firms. Internships offer academic credit, and some offer modest payment. Interns work with lawyers in performing legal research, interviewing clients and witnesses, attending court sessions and doing other law-related work in a professional setting.

### **PRE-LAW SERVICES & ACTIVITIES**

These include internships, moot court competitions, a pre-law student society, special academic advising and assistance with preparing for the LSAT. Pre-Law services include:

- law-related internships for academic credit
- resources about ABA-approved law schools
- information about the LSAT and preparatory materials
- assistance in preparing for law school

- assistance in applying to law school
- connections to alumni network of legal professionals and law students

### **MOOT COURT EXPERIENCE**

This is a credit course offered by the EIU Political Science Department in which students train to represent attorneys skilled in appellate advocacy. EIU Moot Court teams compete at regional and national Moot Court competitions.

### **THE PRE-LAW SOCIETY**

All students who are interested in a career in the law are urged to join. Activities include field trips to law schools, guest speakers, fund-raising events, LSAT prep and special awards. There are three generous scholarships open to pre-law students, one of which is available only to members.
